PRODUCT DESCRIPTION

Chem-Gel 50[®] is an epoxy gel used for patching, bonding, surface sealing, and interior joint sealing. It is semi-flexible with an elongation of 50%.

APPLICATION

Mix equal parts of A and B and apply to clean, dry, prepared surface using a trowel or spatula. Sand may be added if needed. Use dry sand only.

LIMITATIONS

Application at ambient temperature below 40°F. is not recommended. Exposure to temperatures exceeding 150°F. for prolonged periods is not recommended.

PACKAGING

Chem-Gel 50 is available in 2 gallon units and 10 gallon units in metal containers.

CLEAN-UP

Remove uncured Chem-Gel 50 from tools and equipment with a suitable solvent such as xylene or toluene immediately after use.
