PRODUCT DESCRIPTION

Chem-Kit® is a convenient, two component epoxy system which is designed for THREE distinct purposes: 1) for BOLT-SETTING in vertically drilled holes. 2) for WET-BONDING of old-to-new concrete, and 3) as a mortar-mix using dry sand. Chem-Kit is supplied in a 0.85 gallon unit. This product meets ASTM c-881 Type I and Type II.

APPLICATION

This is an easy to use pre-measured unit. Mix all of the part B into all of the part A. If smaller mixes are needed, mix 12 oz. of part A and 5 oz. of part B. Add sand to produce a mortar, or pour or brush where needed.

LIMITATIONS

Application at ambient temperature below 40°F. is not recommended. Exposure to temperatures exceeding 150°E for prolonged periods is not recommended.

PACKAGING

Chem-Kit is available in 47.5 lb. kits. The kit consists of 0.85 gallon unit (resin and harender) and 40 lb. graded aggregate.

Store in a dry area, between 40°F. and 95°F. Protect from direct sunlight.
